A. Schedule to Conditions of Entry

3. <u>Promotion Period:</u>	The Promotion starts at 00:00:00 on 01/04/2021 and closes at 23:59:59 on 31/05/2021.
4. <u>Eligibility:</u>	The Promotion is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Promotion Period, and with a valid identification document and residential address in Malaysia. The Organiser shall reserve the right to request for evidence of identification documents.

There are two [2] methods of participation in the Promotion which is either via postal OR via WhatsApp. All other methods of submission including but not limited to courier service, or POS Laju will be disqualified.</p> <p>d. Unclear, illegible and incomplete WhatsApp Entry will be disqualified.</p> <p>f. The Organiser shall reserve the right to request for evidence of the original Receipt [hardcopy] for verification and prize redemption. Failure to produce the original Receipt upon request will result in disqualification and prize forfeiture.</p> <p>g. 10. <u>Weekly Prizes Judging Details:</u>	<p>a. Since dividing 188888 with 100 will result in a number with decimal value, the number 1888.8 will be rounded down to 1888. [*computation example: 1888, $1888+1888=3776$, $3776+1888=5664$].</p>
<p>13. <u>Additional Terms:</u></p>	<p>a. The Organiser will contact all selected Finalists via the mobile number from which the Organiser received in the Qualified Entries. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the “Terms and Conditions”. Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Promotion Period, make Prize substitutions, cancel, terminate or suspend the Promotion in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Promotion will constitute their acceptance of the Terms and Conditions (as changed).
