<b>Eligibility</b>	1) The Challenge is open to all individual legal residents of Peninsular Malaysia aged 18 years and above as at the start of the Promotion Period, and with a valid identification document and residential address in Peninsular Malaysia. The Organiser shall reserve the right to request for evidence of identification documents.

### **BOOKDOC APPLICATION REGISTRATION**

To take part in the Challenge after receipt of the BookDoc application activation code, Participants are required to:

1. Download the BookDoc application ("BookDoc App") for free from App Store or Google Play store and register for a BookDoc account. For existing BookDoc App users, proceed to step 2.
2. Upon registration or log in - on the BookDoc App home page, click on the NESTLÉ OMEGA PLUS 30 Day Challenge banner and sign up for the Challenge. Enter the unique Activation Code received via WhatsApp.
