B: Conditions of Participation

1. Introduction

1.1 These Conditions of Participation are to be read together with the Schedule to Conditions of Participation. To the extent that there is any inconsistency between the Conditions of Participation and the Schedule to Conditions of Participation, the Schedule to Conditions of Participation prevails. The Conditions of Participation and the Schedule to Condition of Participation shall collectively be referred to as the "Terms and Conditions". Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Participation. Defined terms will be used singular or plural.

- 1.2 The Organizer reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Redemption Period, make Prize substitutions, cancel, terminate, or suspend the Redemption in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Redemption will constitute their acceptance of the Terms and Conditions (as changed).
- 1.3 The Organizer's decision on all matters relating to the Redemption including judging and selection of participant will be final, binding, and conclusive on all Participants, and no correspondence or appeals will be entertained.

2. Redemption Entries

- 2.1 By participating in the Redemption, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.
- 2.2 All costs and expenses incurred and/or arising from the participation in the Redemption, including without limitation, telecommunications, network, Short Messaging Services, postal and all such other charges and out-of-pocket expenses as may be incurred by a Participant during or in connection with the Redemption shall be borne by the Participant.
- 2.3 Proof of submission to participate in the Redemption is not proof of receipt, and the Organizer shall not be liable for any delay, loss, damaged and/or non-receipt of submissions. The Organizer is not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of our telecommunications network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the Internet.

3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Participation is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organizer), from their parents/legal guardians before participating in the Redemption and submitting any personal information.

5. Disqualification

- 5.1 The following entries will be disqualified:
 - (a) unclear, incomplete, duplicate, copies, illegible or incorrect entries; and/or
 - (b) entries that violate the Terms and Conditions, any applicable laws and/or regulations.
- 5.2 In addition, the Organizer reserves the right to disqualify any Participant that:
 - (a) undermines, has, or attempted to undermine the operation of the Redemption by fraud, cheating or deception; and/or
 - (b) are not eligible or unable to provide proof of eligibility to participate in the Redemption for verification by Organizer when requested.

5.3 In the event of a disqualification after a Prize has been awarded, the Organizer reserves the right to demand the return of the Prize or payment of its value from the disqualified Participant.

6. Prizes

9. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organizer, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("NESTLÉ Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Redemption, acceptance of any Prize, and/or the use of the Participant's participation and/or likeness in connection with the Redemption or violation of the Terms and Conditions.

10. Limitation of Liability
