The rounding formula will be performed where the decimal value arises, the number will be rounded down to the nearest single digit number.

A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".

The serial numbers allocated to each Qualified Entry will be tabulated and added up to derive the total number of Qualified Entries ["Total Qualified Entries"]. Assuming the Total Qualified Entries received throughout the Promotion period is 2550, and Grand Prize Winners' entries is 9, Second Prize winners' entries is 9, the Organiser will compute and select the shortlisted winners based on the following example:

The rounding formula will be performed where the decimal value arises, the number will be rounded down to the nearest single digit number.
