

TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1.	Organiser:	Nestlé Products Sdn. Bhd. [197901000966].
2.	Promotion:	PERADUAN NESTLÉ KITKAT PLAY, BREAK & WIN! PS5 EKSKLUSIF DI <u>PETRONAS</u> .
3.	Promotion Period:	The Promotion starts at 00:00:00 on 01/09/2022 and closes at 23:59:59 on 31/10/2022.
4.	Eligibility:	The Promotion is open to all individual legal residents of Malaysia with a valid identification document, aged 18 years and above as at the start of the Promotion Period. The Organiser shall reserve the right to request for evidence of identification documents.
5.	Entry Method:	 a. To participate in the Promotion, purchase a minimum of Ringgit Malaysia Five [RM5] of any participating NESTLÉ KITKAT CONFECTIONERY product ["Products"] as listed below in a single receipt from any Kedai Mesra PETRONAS in-store during the Promotion Period: NESTLÉ KITKAT CONFECTIONERY 2-Finger (17g) [Original – Milk Chocolate]; OR NESTLÉ KITKAT CONFECTIONERY 4-Finger (35g) [Original – Milk Chocolate, Green Tea, Gold, Dark Cookies]; OR NESTLÉ KITKAT CONFECTIONERY CHUNKY (38g) [Milk Chocolate, Cookies & Cream or Raisin & Cookie]; OR NESTLÉ KITKAT CONFECTIONERY BITES (40g). b. The single receipt must come in the form of printed receipts from Kedai Mesra PETRONAS in-store outlet point-of- sale systems. Receipts must be with the final paid amount of Ringgit Malaysia Five [RM5] and above to qualify ["Receipt"]. c. The Receipt must bear the Products purchase, date of purchase, purchase amount, receipt number and name and/or logo of the outlet ["Receipt Details"]. d. During the Winners selection process, the Organiser will allocate serial numbers according to the purchase amount as stated in the Receipt submitted. For every Ringgit Malaysia Five [RM5], the Organiser will allocate one [1] serial number. Please refer clause 7 and clause 8 below.

<u>For example</u>: If you purchase RM25 of Products in a single Receipt during the Promotion Period, the Organiser will allocate five [5] serial numbers.

e. The Promotion participation method is via WhatsApp only. Participant may submit as many entries as they wish but each Receipt is ONLY eligible to one [1] entry via WhatsApp. The Organiser shall reserve the right to disqualify any entries with tampered and/or reprinted and/or duplicated Receipt and/or containing more than one [1] Receipt.

f. WhatsApp entry participation steps:

i. Write on the front of the Receipt your full name and identification number ["Personal Details"].

For example, write on the Receipt:

- ii. Snap one [1] <u>clear and legible</u> picture/image in JPEG Format of one [1] Receipt complete with your Personal Details and Receipt Details ["Image"]. One [1] Image must contain a full picture of one [1] Receipt only.
- iii. Submit one [1] Image via WhatsApp from any number registered in Malaysia to 6018-228 3911 ["Entry"].
- iv. The Organiser WILL auto-reply with an acknowledgement message for each Entry received.
- g. The Organiser will extract all Entries received for further processing. Any unclear, illegible and incomplete Entry will be disqualified automatically.
- h. Participants are required to safe keep the original Receipt. The Organiser shall reserve the right to request for evidence of the original Receipt [hardcopy] for verification and prize redemption. Failure to produce the original Receipt upon request will result in disqualification and prize forfeiture.

6. **Entry Deadline:**

All Entries must be received by the Organiser on or before 23:59:59 on 31/10/2022. All Entries received outside the Promotion Period will be automatically disqualified.

7. Weekly Bonus Prizes and selection of finalists:

- a. There is one [1] Weekly Bonus Prize in the form of a SONY DualSense™ Wireless Controller to be won each week for eight [8] consecutive weeks. In total, there are eight [8] Weekly Bonus Prizes to be won throughout the Promotion Period.

c. Judging Details for selection of Finalists:

The Organiser will allocate serial numbers for each Entry received and approved by the Organiser to be a successful entry each week, throughout the Promotion Period according to the Receipt submitted [each a "Qualified Entry" and collectively the "Qualified Entries"]. A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".

- d. Each week the serial numbers allocated to each Qualified Entry will be tabulated and added up to derive the total number of Qualified Entries ["Total Qualified Entries"]. Assuming that the Total Qualified Entries received for the week is <u>405</u> the Organiser will compute and select the finalists based on the following:
 - i. Weekly selection of one [1] Weekly Bonus Prize Finalists: 405 ÷ 2 = 202.5. Since dividing 405 with 2 will result in a number with decimal value, the number 202.5 will be rounded down to 202. The following Participant with Qualified Entries of the week bearing the serial numbers 202 will be selected.

- c. Judging Details for selection of Finalists:
 - The Organiser will allocate serial numbers for each Entry received and approved by the Organiser to be a successful entry each month, throughout the Promotion Period according to the Receipt submitted [each a "Qualified Entry" and collectively the "Qualified Entries"]. A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".
- d. Each month the serial numbers allocated to each Qualified Entry will be tabulated and added up to derive the total number of Qualified Entries ["Total Qualified Entries"]. Assuming that the Total Qualified Entries received for the month is <u>809</u> the Organiser will compute and select the finalists based on the following:
 - i. Monthly selection of three [3] Monthly Grand Prize Finalists: 809 ÷ 3 = 269.6. Since dividing 809 with 3 will result in a number with decimal value, the number 269.6 will be rounded down to 269. The following 3 Participants with Qualified Entries of the month bearing the following

serial numbers will be selected: 269*, 538* and 807. [*computation example: **269**, 269+269=**538**].

9. Additional Terms:

- a. The Organiser will contact all selected Finalists via WhatsApp to the mobile number from which the Organiser received in the Qualified Entries. Each selected Finalist will be given one [1] question to answer. The selected Finalists must answer the question posted by the Organiser correctly in order to win the Prizes. Failure to answer correctly and/or failure to answer the question posted by the Organiser within the time stated will result in the Prize being forfeited. The Organiser will not be held liable in the event the selected Finalists cannot be contacted for whatever reasons.

- epidemic/pandemic outbreaks) and for any act or default by any third-party suppliers or vendors.
- j. The Organizer shall not be liable for any loss or damage that occurs to the prizes during the delivery process. Any other additional costs (i.e., travel expenses, transportation cost, duties and taxes) involved to redeem or collect the prize shall be borne by the winner at their own cost.

B. Conditions of Entry

1. Introduction

- 1.1 This Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between these conditions of entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the "Terms and Conditions". Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Promotion Period, make Prize substitutions, cancel, terminate or suspend the Promotion in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Promotion will constitute their acceptance of the Terms and Conditions (as changed).
- 1.3 The Organiser's decision on all matters relating to the Promotion including judging and selection of winners will be final, binding and conclusive on all Participants, and no correspondence or appeals will be entertained.

2. Promotion Entries

- 2.1 By submitting an entry to the Promotion, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.
- 2.2 All costs and expenses incurred and/or arising from the participation in the Promotion, including without limitation, telecommunications, network, Short Messaging Services, postal and all such other charges and out-of-pocket expenses as may be incurred by a Participant during or in connection with the Promotion shall be borne by the Participant.

2.3 Proof of submission of an Entry is not proof of receipt, and the Organiser shall not be liable for any delay, lost, damaged and/or non-receipt of submissions. The Organiser is not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of our telecommunications network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the Internet.

3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Promotion and submitting any personal information.
- 3.2 The Organiser may require a Participant to provide proof of eligibility to participate in the Promotion including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.

4. Ineligibility

The following groups of persons shall not be eligible to participate in the Promotion:

- 5.2 In addition, the Organiser reserves the right to disqualify any Participant that:
 - (a) undermines, has or attempted to undermine the operation of the Promotion by fraud, cheating or deception; and/or
 - (b) are not eligible or unable to provide proof of eligibility to participate in the Promotion for verification by Organiser when requested.
- 5.3 In the event of a disqualification after a Prize has been awarded, the Organiser reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

6. Prizes

- 6.1 The Organiser, its agents, sponsors and representatives shall have no liability to any Participant who defaults in collecting the Prizes in accordance with the Prize Claim/Delivery Date in any respect whatsoever. (a) Tickets to an Event:

The Organiser is not liable for any cancellation or re-scheduling that may prevent a Prize fulfilment. Tickets can only be used on the date(s) specified on the ticket.

The Organiser has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

9. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Nestlé Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Promotion, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Promotion or violation of the Terms and Conditions.

10. Limitation of Liability

- 11.5 Where the Terms and Conditions of the Promotion is prepared in English and any other language(s) in the event of any inconsistency between the English language and the other language(s), the English language version shall prevail and govern in all respects.
- 11.6 The Terms and Conditions of the Promotion shall be construed, governed and interpreted in accordance the laws of Malaysia.
