

TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1. <u>Organiser:</u>	Nestlé Products Sdn. Bhd. [197901000966].
2. <u>Promotion:</u>	PERADUAN NESTLÉ KITKAT WIN GOLD.
3. <u>Promotion Period:</u>	The Promotion starts at 00:00:00 on 08/01/2021 and closes at 23:59:59 on 28/02/2021.
4. <u>Eligibility:</u>	The Promotion is open to all individual legal residents of Malaysia with a valid identification document, aged 18 years and above as at the start of the Promotion Period. The Organiser shall reserve the right to request for evidence of identification documents.
5. <u>Entry Method:</u>	<p>a. To participate in the Promotion, purchase a minimum of Ringgit Malaysia Eight [RM8] of any NESTLÉ KITKAT CONFECTIONERY product [“Products”] in a single receipt from any outlets [in-store & online store] during the Promotion Period.</p> <p>i. E-receipts for online purchases with promotion codes and/or discount vouchers must be with the final paid amount of Ringgit Malaysia Eight [RM8] and above to qualify [“Receipt”].</p> <p>ii. Unclear, illegible and incomplete Entry will be disqualified.</p> <p>e. The Organiser shall reserve the right to request for evidence of the original Receipt [hardcopy] for verification and prize redemption. 9. <u>Judging Details – Weekly Prizes:</u>	<p>a. As part of the Weekly Prize Finalists' selection process, the Organiser will allocate serial numbers for each WhatsApp Entry received and approved by the Organiser to be a successful entry each week, throughout the Promotion Period according to the Receipt submitted [each a "Qualified Entry" and collectively the "Qualified Entries"]. A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".</p> <p>b. Each week the serial numbers allocated to each Qualified Entry will be tabulated and added up to derive the total number of Qualified Entries ["Total Qualified Entries"]. <p>11. <u>Judging Details – Main Prizes:</u></p>	<p>a. To select the Finalists, all Qualified Entries collected and processed by the Organiser during the weekly winners’ selection process and throughout the Promotion Period will separately be allocated a set of serial numbers starting from serial number “1”.</p> <p>b. Selection of twelve [12] Second Prize Finalists: $58889 \div 12 = 4907.4$. Since dividing 58889 with 12 will result in a number with decimal value, the number 4907.4 will be rounded down to 4907. <p>13. <u>Judging Details – TESCO Weekly Prizes:</u></p>	<p>a. To select the TESCO Weekly Prizes Finalists, ALL <u>Qualified WhatsApp Entries with TESCO Receipts</u> collected and processed during the weekly selection process, the Organiser will allocate serial numbers for each WhatsApp Entry received and approved by the Organiser to be a successful entry each week, throughout the Promotion Period according to the TESCO Receipt submitted [each a “TESCO Qualified Entry” and collectively the “TESCO Qualified Entries”]. <p>14. <u>Additional Terms:</u></p>	<p>a. The Organiser will contact all selected Finalists via the mobile number from which the Organiser received in the Qualified Entries. Each selected Finalists will be given one [1] question to answer. The selected Finalists must answer the question posted by the Organiser correctly in order to win the Prizes. B. Conditions of Entry

1. Introduction

- 1.1 This Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between these conditions of entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the “Terms and Conditions”. Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Promotion Period, make Prize substitutions, cancel, terminate or suspend the Promotion in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Promotion will constitute their acceptance of the Terms and Conditions (as changed).
- 1.3 The Organiser’s decision on all matters relating to the Promotion including judging and selection of winners will be final, binding and conclusive on all Participants, and no correspondence or appeals will be entertained.

- 2.1 By submitting an entry to the Promotion, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.

3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Promotion and submitting any personal information.
- 3.2 The Organiser may require a Participant to provide proof of eligibility to participate in the Promotion including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.

4. Ineligibility

The following groups of persons shall not be eligible to participate in the Promotion:

- 5.1 The following entries will be disqualified:
- (a) unclear, incomplete, duplicate, copies, illegible or incorrect entries; and/or

- 5.2 In addition, the Organiser reserves the right to disqualify any Participant that:
- (a) undermines, has or attempted to undermine the operation of the Promotion by fraud, cheating or deception; and/or
 - (b) are not eligible or unable to provide proof of eligibility to participate in the Promotion for verification by Organiser when requested.

5.3 In the event of a disqualification after a Prize has been awarded, the Organiser reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

6.1 The Organiser, its agents, sponsors and representatives shall have no liability to any Participant who defaults in collecting the Prizes in accordance with the Prize Claim/Delivery Date in any respect whatsoever. Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Nestlé Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Promotion, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Promotion or violation of the Terms and Conditions,
