

**TERMS AND CONDITIONS**

**A: Schedule to Conditions of Entry**

<b>Contest Period</b>	The Contest starts at 00:00:00 on 1 <sup>st</sup> March 2023 and closes at 23:59:59 on 30 <sup>th</sup> April 2023.
<b>Eligibility</b>	The Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Malaysia.

Handwritten receipts, purchase orders, delivery notes will <b>not</b> be accepted as Proof of Purchase for the Contest.</p> <p><b>Step 2:</b> Prepare a <b>baked</b> dish incorporating any Product(s) as one of the main ingredients. Originality, good presentation, easy preparation, and nutrition of the recipe will contribute to judging marking. Participants are free to add other ingredients to the dish.</p> <p><b>Step 3:</b> Record a minimum 30 second or up to a maximum of 60 second creative video of the step-by-step baking process. ### **1. Introduction**

- 1.1 This Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between the Conditions of Entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the "Terms and Conditions". Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Contest Period, make Prize substitutions, cancel, terminate, or suspend the Contest in whole or in part.
